Rules & Regulations

1. Dancing will conform to S.O.B.H.D. rules. Judge's decision is final.
2. Registration is 9:45 AM for morning events; 12:30 PM for afternoon events.
3. Events begin at 10:30 AM for Primary, Beginner & Novice; 1:00 PM for Intermediate & Premier
4. Pre-Premier events will be divided into age groups according to entries received.
5. Events will begin with Highland events.
6. FUSTA & SCOTDANCE cards must be shown at time of registration.
7. Medals will be awarded for all events.
8. Trophies will be awarded to the dancer with the highest points on all four dances of each class.
9. Primary dancers will receive medals only.
10. A special award will be presented to the "Most Promising Dancer".
11. We reserve the right to cancel any event due to lack of participation: should this occur, competitors will be notified prior to the day before the competition.
12. Entries received on or before Friday, April 23 that include a self-addressed stamped envelope will receive a competitor's pass.
13. Entries received after April 23 will not receive a pass and must pay a gate fee in addition to entry fee.
14. **NO** entries will be accepted on the field.
15. \$1 from each entry will be donated to FUSTA.
